ANSI/AIHA Z10 Accreditation**

STR-Registrar to offer accredited certification and registration services to help businesses reduce the occurrence and cost of occupational injuries, illnesses, and fatalities.

Enfield, CT, May 8, 2008 – STR-Registrar, LLC, an STR Group company, recently became the first ANAB Accredited Certification Body in North America to be awarded ANSI/AIHA Z10-2005 Occupational Health & Safety Management Systems (OHSMS) Accreditation. This accreditation enables STR-Registrar, LLC to offer accredited certification and registration services to organizations that want to implement the voluntary ANSI Z10 standard in their workplace. Implementation of the ANSI Z10 standard can help businesses minimize workplace risks, mitigate hazards, and reduce the occurrence and cost of occupational injuries, illnesses, and fatalities on the job.

According to the American Society of Safety Engineers, businesses spend \$171 billion a year on costs associated with occupational injuries and illnesses. These expenditures, which can comprise as much as 5 percent of a company's total costs, come straight out of company profits. However, businesses that establish safety and health management systems can reduce their injury and illness costs by 20 to 40 percent.

The ANSI Z10 standard provides organizations with an effective tool for continual management and improvement of their occupational health and safety performance. With a focus on effective employee protection and the identification of risks and hazards, ANSI Z10 addresses the following elements of a company's management system structure: management leadership, active employee participation, analysis of the worksite to identify serious safety and health hazards of all types, training, evaluation, risk controls, audits, incident/accident investigations, corrective actions, and management review.

STR-Registrar, LLC recently awarded the first ANAB Accredited ANSI Z10 certification in North America to Doncasters Trucast, an investment casting manufacturer based in Newberry, South Carolina. STR-Registrar, LLC is now working with Nucor Steel to certify one of their thin-slab sheet mills located in Crawfordsville, Indiana. A June 2008 certification is expected.

“Companies that choose to implement the ANSI Z10 standard are demonstrating a commitment to safety that goes beyond the requirements of OSHA,” said Bryce Carson, Sr., President and CEO of STR-Registrar, LLC. “In addition to the direct benefits of improved employee health and safety, having a management system structure in place increases productivity, financial performance, and employee satisfaction.”

“The ANSI/AIHA-Z10 certification has impacted our company in many positive ways. It prompted us to involve employees in health and safety, which gives us a different view of operator concerns. The standard also prompted us to compile all records so that all personnel can view and understand our policy and procedures,” said Angie Wofford, Quality Manager for Doncasters Trucast. “Safety is number one to us and ANSI/AIHA -Z10 will continue to be a positive influence in continuing to ensure safety for all of our employees. We are honored to be the first company in the U.S. to be compliant to the standard.”
